- Butch reached out to Lupine Florist and obtained the following pricing:
 - \$18.99 for potted plant
 - \$8.99 - \$12.99 for cut bunches of tulips (volume discounts may be possible)
 - We agreed that the bunches sale price point of \$15 would be the most reasonable. Cost for credit card transaction would be ~\$0.75.
- Joyce inquired if the tulips would be available in early April (not sure of growing season). Butch will inquire.
- The group discussed the timeframe for when we would want to have this done
 - It was generally agreed that tulips would be most desired for Easter weekend (Saturday, April 3 delivery)
- Butch will obtain clarification on availability, lead time, discount for quantities and photographs of bunches
