Discussion: <ul style="list-style-type: none">Butch reported that he is continuing his outreach to generate foursome groups for the tournament. He has lots of leads and has already made several outreaches. He will work to follow-up and lock in commitments. Fagundes Plumbing has signed up for a foursome.
